8	dated Farm and Rural Development Act (7 U.S.C.
9	1991(a)).
10	"(2) Conservation practice.—The term
11	'conservation practice' means a site-specific land
12	management practice or activity, or a supporting
13	structural practice, that is part of an implemented
14	management system designed to address a priority
15	resource of concern.
16	"(3) Conservation security contract.—
17	The term 'conservation security contract' means a
18	contract entered into under this subchapter.
19	"(4) Conservation Security Program.—The
20	term 'conservation security program' means the pro-
21	gram established under section 1238A(a).
22	"(5) STRUCTURAL PRACTICE.—The term 'struc-
23	tural practice' means a site-specific, constructed con-
24	servation practice that is integrated with and essen-
25	tial to the successful implementation of the system

1	of land management practices and activities that are
2	the basis of a conservation security contract.
3	"(6) Management intensity.—The term
4	'management intensity' means the scope and com-
5	prehensiveness of practices or activities taken by a
6	producer to address a priority resource of concern.
7	"(7) New practice payment.—The term 'new
8	practice payment' means a payment determined in
9	accordance with section $1238C(c)(3)$.
10	"(8) Nondegradation standard.—The term
11	'nondegradation standard' means the level of natural
12	resource conservation and environmental manage-
13	ment measures required to improve and sustain the
14	status and condition of natural and environmental
15	resources to a level that, as determined by the Sec-
16	retary—
17	"(A) prevents impairment of soil, water,
18	and air quality and the quality of fish and wild-
19	life habitat; and
20	"(B) sustains the long-term productivity of
21	agricultural resources.
22	"(9) Priority resource of concern.—The
23	term 'priority resource of concern' means a resource
24	of concern identified by the Secretary, consistent
25	with the requirements of section 1238C(a), that

1	must be addressed by participants in the conserva-
2	tion security program in a particular watershed or
3	other area within that State.
4	"(10) Producer.—The term 'producer' means
5	an owner, operator, landlord, tenant, or share-
6	cropper that—
7	"(A) shares in the risk of producing any
8	crop or livestock; and
9	"(B) is entitled to share in the crop or
10	livestock available for marketing from a farm
11	(or would have shared had the crop or livestock
12	been produced).
13	"(11) Resource-specific index.—The term
14	'resource-specific index' means an index developed
15	by the Secretary that estimates the comprehensive-
16	ness and intensity of the management measures em-
17	ployed by a producer to address a priority resource
18	of concern on an agricultural operation for purposes
19	of determining eligibility and payments for partici-
20	pants in the conservation security program.
21	"(12) Stewardship base payment.—The
22	term 'stewardship base payment' means a payment
23	determined in accordance with section $1238C(c)(2)$

1 "SEC. 1238A, CONSERVATION SECURITY PROGRAM.

1	"SEC. 1238A. CONSERVATION SECURITY PROGRAM.
2	"(a) Establishment and Purpose.—The Sec-
3	retary shall establish, and for each of fiscal years 2012
4	through 2017, carry out a conservation security program
5	to assist producers in improving environmental quality by
6	addressing priority resources of concern in a comprehen-
7	sive manner.
8	"(b) Eligible Producers.—To be eligible to par-
9	ticipate in the conservation security program, a producer
10	shall—
11	"(1) demonstrate that the producer is address-
12	ing at least one priority resource of concern to at
13	least the minimum level of management intensity re-
14	quired by section 1238C(b)(2);
15	"(2) develop and submit to the Secretary, and
16	obtain the approval of the Secretary of, a conserva-
17	tion plan that includes a schedule of new conserva-
18	tion practices and activities designed to increase,
19	over the term of the conservation security contract,
20	the level of management intensity with which the
21	producer is addressing a priority resource of concern
22	or priority resources of concern, consistent with the
23	requirements of subsection (e); and
24	"(3) enter into a conservation security contract
25	with the Secretary.

"(c) ELIGIBLE LAND.—

1	"(1) In general.—Except as provided in para-
2	graph (2), private agricultural land (including crop-
3	land, grassland, prairie land, improved pasture land,
4	forest land and rangeland) and land under the juris-
5	diction of an Indian tribe (as defined by the Sec-
6	retary) shall be eligible for enrollment in the con-
7	servation security program.
8	"(2) Exclusions.—
9	"(A) LAND ENROLLED IN OTHER CON-
10	SERVATION PROGRAMS.—Except as provided in
11	subsection (f)(3)(A), the following lands are not
12	eligible for enrollment in the conservation secu-
13	rity program:
14	"(i) Lands enrolled in the conserva-
15	tion reserve program under subchapter B
16	of chapter 1.
17	"(ii) Land enrolled in the wetlands re-
18	serve program established under sub-
19	chapter C of chapter 1.
20	"(iii) Land enrolled in the grassland
21	reserve program established under sub-
22	chapter C of chapter 2.
23	"(B) Conversion to Cropland.—Land
24	used for crop production after October 1, 2011,
25	that had not been planted, considered to be

1	planted, or devoted to crop production for at
2	least 4 of the 6 years preceding that date (ex-
3	cept for land enrolled in the conservation re-
4	serve program or that has been maintained
5	using long-term crop rotation practices, as de-
6	termined by the Secretary) shall not be the
7	basis for any payment under the conservation
8	security program.
9	"(d) ECONOMIC USES.—With respect to eligible land
10	covered by a conservation security contract, the Secretary
11	shall permit economic uses of the land that—
12	"(1) maintain the agricultural nature of the
13	land; and
14	"(2) are consistent with the conservation pur-
15	poses of the conservation security program.
16	"(e) Conservation Security Contracts.—
17	"(1) In general.—After a determination that
18	a producer is eligible for the conservation security
19	program, and on approval of the conservation plan
20	of the producer, the Secretary shall enter into a con-
21	servation security contract with the producer to en-
22	roll the land to be covered by the contract in the
23	conservation security program. A producer may not
24	simultaneously be a party to more than one con-
25	servation security contract.

1	"(2) Term.—A conservation security contract
2	shall be for a term of 5 years.
3	"(3) Provisions.—The conservation security
4	contract of a producer shall—
5	"(A) include a conservation plan approved
6	by the Secretary;
7	"(B) describe the land covered by the con-
8	servation security contract, except that all the
9	acres of the agricultural operation that are
10	under the producer's effective control at the
11	time the producer enters into a conservation se-
12	curity contract shall be covered by the conserva-
13	tion security contract;
14	"(C) state the amount of the stewardship
15	base payment (determined in accordance with
16	section 1238C(c)(2)) the Secretary agrees to
17	make to the producer each year of the conserva-
18	tion security contract;
19	"(D) describe the new conservation prac-
20	tices and activities the producer agrees to im-
21	plement during the term of the conservation se-
22	curity contract in order to increase the level of
23	management intensity with which the producer
24	addresses a priority resource of concern or pri-

1	ority resources of concern, as designated by the
2	Secretary under section 1238C(a)(1);
3	"(E) state the amounts of the new practice
4	payments the Secretary agrees to make to the
5	producer upon implementation of the new prac-
6	tices and activities described in the conservation
7	security contract; and
8	"(F) include such other provisions as the
9	Secretary determines necessary to ensure the
10	conservation purposes of the conservation secu-
11	rity program are met.
12	"(4) On-farm research and demonstra-
13	TION OR PILOT TESTING.—The Secretary may ap-
14	prove a conservation security contract that in-
15	cludes—
16	"(A) on-farm conservation research and
17	demonstration activities; and
18	"(B) pilot testing of new technologies or
19	innovative conservation practices.
20	"(f) Modification.—
21	"(1) Modification at option of the pro-
22	DUCER PROHIBITED.—In order to reduce unneces-
23	sary administrative and technical assistance costs,

22	necessary to ensure that national, State, and local

20	"(c) Pilot Program for Comprehensive Con-
21	SERVATION PLANNING.—
22	"(1) PILOT PROGRAM REQUIRED.—The Sec-
23	retary shall establish a pilot program to undertake
24	comprehensive conservation planning to assist pro-
25	ducers before they submit an application for assist-

1	ance under any of the conservation programs au-
2	thorized by this subtitle.
3	"(2) Conservation planning assistance.—
4	The Secretary shall undertake pilot projects under
5	the pilot program in the locations specified in para-
6	graph (3) to assist producers by making a com-
7	prehensive assessment of the resource concerns,
8	needs, and alternative solutions for the producer's
9	entire operation, as determined by the Secretary, fol-
10	lowing the procedures in the Natural Resources Con-

12	assistance shall be provided by the Secretary directly
13	or through third party providers certified by the Sec-

23	prehensive conservation planning shall be under-

3	and publish a report, available to the public, of the
4	results of the assessment. Such assessments shall be
5	undertaken in the second year and the fifth year of
6	the pilot program.
7	"(d) Funding.—
8	"(1) AVAILABILITY OF FUNDS.—Of the funds
9	made available under section 1241(a)(6) for fiscal
10	years 2008 through 2012, the Secretary shall use
11	\$20,000,000 for each of fiscal years 2008 through

13	"(2) Outreach for certain producers.—

4	WATER QUANTITY PRIORITY AREAS.—The Secretary

7	"(2) Establishment.—The Secretary shall es-
8	tablish a regional water enhancement program in ac-
9	cordance with this section to improve water quality
10	or water quantity on a regional scale to benefit
11	working agricultural land and other lands sur-
12	rounding agricultural land.
13	"(c) Selection of Partners.—
14	"(1) Solicitation of Partnership Pro-
15	POSALS.—Not later than 90 days after the date of
16	the enactment of [the 2007 Farm Bill], the Sec-
17	retary shall invite prospective partners to submit
18	competitive grant proposals for regional water en-
19	hancement partnerships.
20	"(2) Elements.—To be eligible for consider-
21	ation for participation in the program, a proposal
22	submitted by a partner shall contain the following
23	elements:

1	"(A) Identification of the exact geographic
2	area for which the partnership is proposed,
3	which may be based on—
4	"(i) a watershed (or portion thereof);
5	"(ii) an irrigation, water, drainage
6	district, including service area;
7	"(iii) some other geographic area with
8	characteristics making it suitable for land-
9	scape-wide program implementation, as
10	may be determined by the Secretary.
11	"(B) Identification of the water quality or
12	water quantity issues that are of concern in the
13	area.
14	"(C) A method for determining a baseline
15	assessment of water quality, water quantity,
16	and other resource conditions in the region.
17	"(D) A detailed description of the proposed
18	regional water enhancement activities to be un-
19	dertaken in the area, including an estimated
20	timeline and budget for each activity.
21	"(E) A description of the performance
22	measures to be used to gauge the effectiveness
23	of the regional water enhancement activities.

1	"(F) A description of other regional water
2	enhancement activities carried out by the Sec-
3	retary.
4	"(G) A description of regional water en-
5	hancement activities carried out by partners
6	through other means.
7	"(3) Selection of Proposals.—The Sec-
8	retary shall award grants competitively, based on the
9	following criteria applied by the Secretary:
10	"(A) Proposals that will result in the inclu-
11	sion of the highest percentage of agricultural
12	lands in the area.
13	"(B) Proposals that will result in the high-
14	est percentage of on-the-ground activities versus
15	administrative costs.
16	"(C) Proposals that will provide the great-
17	est contribution to sustaining or enhancing ag-
18	ricultural production in the area or rural eco-
19	nomic development.
20	"(D) Proposals that include performance
21	measures that will allow post-activity conditions
22	to be satisfactorily measured to gauge overall
23	effectiveness.
24	"(E) Proposals that will capture surface-
25	water runoff on farms through the construction.

1	improvement, or maintenance of irrigation
2	ponds.
3	"(4) Duration.—Grants under this subsection
4	shall be made on a multi-year basis, not to exceed
5	5 years total, except that the Secretary may termi-
6	nate a grant earlier if the performance measures are
7	not being met.
8	"(d) Partnership Agreements.—
9	"(1) Generally.—Not later than 30 days
10	after the award of a grant to a partner under sub-
11	section (c), the Secretary shall enter into a partner-
12	ship agreement with the grant recipient. At a min-
13	imum, the agreement shall contain—
14	"(A) a description of the respective duties
15	and responsibilities of the Secretary and the
16	partner in carrying out regional water enhance-
17	ment activities; and
18	"(B) the criteria that the Secretary will
19	use to measure the overall effectiveness of the
20	regional water enhancement activities funded by
21	the grant in improving the water quality or
22	quantity conditions of the region relative to the

24	"(2) ACCEPTANCE OF CONTRIBUTIONS.—The
25	Secretary may accept and use contributions of non-

3	"(e) Modification of Secretarial Authority.—

5	gional water enhancement activities in an area, the Sec-

9	tivities.

14	ticable, consistent with the requirements of subsection (d),

18	address the resource concerns facing producers, ranchers,
19	and nonindustrial private forest landowners, including
20	specifically projects and initiatives that are designed—
21	"(1) to achieve improvements in water quality
22	in watersheds impacted by agriculture, particularly
23	by increasing the participation of producers in im-
24	plementing best management practices in a water-

1	shed or developing environmentally and economically
2	viable alternative uses for manure and litter;
3	"(2) to achieve improvements in air quality in
4	a geographical area where agricultural operations
5	impact air quality;
6	"(3) to conserve water for environmental pur-
7	poses, such as enhanced in stream flows or aquifer
8	recharge in regions, States, or local areas where
9	water quantity is a concern;
10	"(4) to assist in carrying out a State Wildlife
11	Habitat Incentives Program plan or other State, re-
12	gional, or national conservation initiative.
13	"(5) to control invasive species on rangeland or
14	other agricultural land through the cooperative ef-
15	forts of multiple producers in a geographical area;
16	"(6) to address a specific resource of concern or
17	set of concerns on private, non-industrial forest land;
18	"(7) to reduce losses of pesticides to the envi-
19	ronment by engaging multiple producers in a geo-
20	graphic area in adoption of integrated pest manage-
21	ment practices and approaches;
22	"(8)) to protect farmland and ranch land fac-
23	ing development pressures from being converted to
24	non-agricultural use; or

1	"(9) to assist producers in carrying out good
2	management practices to enhance food safety.
3	"(g) Cost Share.—The Secretary shall not require
4	more than 25 percent of the cost of a project or initiative
5	supported under a grant or agreement entered into under
6	this section to come from non-Federal sources. However,
7	the Secretary may give higher priority to projects or initia-
8	tives offering to cover a higher percentage of the cost of
9	the project or initiative from non-Federal sources.
10	"(h) Funding.—
11	"(1) Set-aside.—Of the funds provided for
12	each of fiscal years 2008 through 2012 to implement

23	allocation shall be made on a similar basis as what

1	"(3) Unused funding.—Any funds reserved
2	for a fiscal year under paragraph (1) that are not
3	obligated by April 1 of that fiscal year may be used
4	to carry out other activities under conservation pro-
5	grams under subtitle D during the remainder of that
6	fiscal year.".

15	lowing new subsection:
16	"(c) Single, Simplified Application Process.—
17	"(1) Establishment.—In carrying out any of

"(4) Conservation program applicant are adequately assessed by the Secretary, directly or through a third-party provider under section 1242, in order to determine the programs under this title that best matches the needs of the applicant, with the approval of the applicant, the Secretary may convert the initial application into the specific application for assistance for the program of choice. To the maximum extent practical, the specific application for conservation program assistance shall be carried out by the Secretary by requesting only that specific further information from the applicant that is not already available to the Secretary.

"(5) Implementation and notification.—
Not later than one year after the date of the enactment of [the Farm Bill], the Secretary shall complete the requirements of this subsection and shall

22	SEC. 2407. PROMOTION OF MARKET-BASED APPROACHES
23	TO CONSERVATION.
24	(a) FINDINGS.—Congress finds the following:

4	signed value in the market place or lack a private

17	(b) Market-Based Approaches.—Subtitle E of

21	"SEC. 1245. MARKET-BASED APPROACHES TO CONSERVA-

23	"(a) Implementation.—To facilitate the develop-

22	agement and agricultural activities in order to facili-
23	tate the development of credit markets for conserva-
24	tion and land management activities that are agri-

1	"(2) Chairperson.—The Secretary of Agri-
2	culture shall serve as chair of the Environmental
3	Services Standards Board.
4	"(3) Membership.—The Environmental Serv-
5	ices Standards Board shall be comprised of the Sec-
6	retary of Agriculture, the Secretary of the Interior,
7	the Secretary of Energy, the Secretary of Com-
8	merce, the Secretary of Transportation, the Admin-
9	istrator of the Environmental Protection Agency, the
10	Commander of the Army Corps of Engineers, and
11	such other representatives as determined by the
12	President.
13	"(4) Subcommittees.—The Environmental
14	Services Standards Board may form subcommittees
15	to address specific issues.
16	"(c) Dissemination of Performance Stand-
17	ARDS.—Federal agencies are authorized to adopt perform-
18	ance standards developed by the Environmental Services
19	Standards Board for quantifying environmental services
20	that establish credits to meet requirements of environ-
21	mental and conservation programs.
22	"(d) Funding .—There is authorized to be appro-
23	priated \$50,000,000 to carry out this section. Amounts
24	so appropriated shall remain available until expended.
25	"(e) Definitions.—In this section:

1	"(1) Baseline.—The term 'baseline' means a
2	level of effort or performance that is expected to be
3	met before an entity can generate marketable cred-

5	"(2) Performance standard.—The term
6	'performance standard' means a defined level of en-
7	vironmental performance, expressed as a narrative
8	or measurable number, which specifies the minimum
9	acceptable environmental performance of an oper-

11	SEC. 2408. ESTABLISHMENT OF STATE TECHNICAL COM-
12	MITTEES AND THEIR RESPONSIBILITIES.
13	Subtitle G of title XII of the Farm Security Act of
14	1985 (16 U.S.C. 3861, 3862) is amended to read as fol-
15	lows:
16	"Subtitle G—State Technical

18	"SEC. 1261. ESTABLISHMENT OF STATE TECHNICAL COM-
19	MITTEES.
20	"(a) Establishment.—The Secretary shall estab-
21	lish a technical committee in each State to assist the Sec-

24	this title.

1	"(b) Composition.—Each State technical committee
2	shall be composed of agricultural producers and other pro-
3	fessionals that represent a variety of disciplines in the soil,
4	water, wetland, and wildlife sciences. The technical com-
5	mittee for a State shall include representatives from
6	among the following:
7	"(1) The Natural Resources Conservation Serv-
8	ice.
9	"(2) The Farm Service Agency.
10	"(3) The Forest Service.
11	"(4) The Cooperative State Research, Edu-
12	cation, and Extension Service.
13	"(5) The State fish and wildlife agency.
14	"(6) The State forester or equivalent State offi-
15	cial.
16	"(7) The State water resources agency.
17	"(8) The State department of agriculture.
18	"(9) The State association of soil and water
19	conservation districts.
20	"(10) At least 12 agricultural producers rep-
21	resenting the variety of crops and livestock or poul-
22	try grown within the State.
23	"(11) Nonprofit organizations within the mean-
24	ing of section 501(c)(2) of the Internal Revenue
25	Code of 1986 with demonstrable conservation exper-

1	tise and experience working with agriculture pro-
2	ducers in the State.
3	"(12) Agribusiness.
4	"(c) Subcommittees.—A State technical committee
5	shall convene one or more subcommittees to provide tech-
6	nical guidance and implementation recommendations. The
7	topics that a subcommittee shall address shall include, at
8	a minimum, the following:
9	"(1) Establishing priorities and criteria for
10	State initiatives under the programs in this title, in-
11	cluding the review of whether local working groups
12	are addressing those priorities.
13	"(2) Issues related to private forestlands pro-
14	tection and enhancement.
15	"(3) Issues related to water quality and water
16	quantity.
17	"(4) In those States where applicable, issues re-
18	lated to air quality.
19	"(5) Issues related to wildlife habitat, including
20	the protection of nesting wildlife.
21	"(6) Issues related to wetland protection, res-
22	toration, and mitigation requirements.
23	"(7) Other issues as the Secretary determines
24	would be useful.

1 "SEC. 1262. RESPONSIBILITIES.

- 2 "(a) IN GENERAL.—Each State technical committee
- 3 established under section 1261 shall meet regularly to pro-
- 4 vide information, analysis, and recommendations to appro-
- 5 priate officials of the Department of Agriculture who are
- 6 charged with implementing the conservation provisions of

- 8 "(b) Public Notice and Attendance.—Each
